Sub: Rates of Terminal Charges to be collected by Port Trust Railways directly from customers from 01.04.2013 to 31.03.2015.

Ref: Rates Circular No.10 of 2011 and 88 of 2007.


In terms of Rates Circular No.10 of 2011, the rates for Terminal Charges to be collected by different Port Trust Railways for the period from 01.04.2011 to 31.03.2013 was conveyed to Zonal Railways.

The matter has been examined and it has been decided to revise the rates of Terminal Charges to be collected by Port Trust Railways, of Mumbai, Kolkata, Chennai, Cochin, Paradip, Mormugao and Vishakhapatnam (for Vishakhapatnam in respect of traffic passing through north holding yard only), for the period 01.04.2013 to 31.03.2015 as Rs. 16.95 per tonne for all type of traffic. ✓

In respect of Vishakhapatnam Port Trust (Ore Exchange Yard), Terminal Charge rate will be 80% of the rates indicated above.

The terms and conditions, notified vide Rates Circular No.88 of 2007, in respect of collection and payment of Terminal Charges will continue to apply unchanged.

Sub: Revision in the rates of Demurrage, Wharfage and Stabling Charges

In supersession of Board's letters under reference, it has been decided to revise the rates of Demurrage, Wharfage and Stabling Charges w.c.f.01.04.2013 and, accordingly amend the following extant instructions, as under:

Para 3.1 of Rates Circular No.74 of 2005

“3.1 Demurrage charge shall be levied @Rs.150/- per 8-wheeled wagon per hour, or part of an hour, for detention of wagon in excess of the permissible free time for loading or unloading.”

Para 4 of Rates Circular No.21 of 2007

“4 Wharfage Rates

Wharfage Charge will be levied on per wagon per hour basis uniformly for all types of wagons, whether 4 wheeler or 8 wheeler or any other type.

Group I	Rs.150/- per wagon per hour or part thereof
Group II	Rs.120/- per wagon per hour or part thereof
Group III	Rs.75/- per wagon per hour or part thereof

Para 2.3 of Rates Circular No.97 of 2006

“2.3 Rate of Stabling Charge will be Rs.500/- per wagon per day or part of a day, from the time of arrival to the time of removal.”

Sub: Revision of rates on Mumbai Port Trust Railway.


Sanction of the Central Government is hereby communicated for the revision of siding charges in respect of Mumbai Port Trust Railway as per the details given below:

(i) Haulage Charge on through traffic	Rs.1350/- per 8 wheeler wagon
(ii) Siding Charge on foreign railway traffic	Rs.310/- per 8 wheeler wagon
(iii) <u>Rebooking Charges</u> At Owner's Risk	Rs.1675/- per 8 wheeler wagon
At Railway Risk	Rs.2010/- per 8 wheeler wagon
(iv) Infringement Charges	Rs.2735/- per 8 wheeler wagon

These charges for 4-wheeler wagon will be 0.40 times of the charges of the 8 wheeler wagon.

The revised charges sanctioned above may be given effect from a suitable date after giving proper notice to the public and to the other Railways. A copy of your detailed notification may be endorsed to the Ministry of Railways.
