Sub: Handling of Jumbo Bags with Dry Bulk cargo viz PTA, Zeeolite, Magnesium Oxide, Micro Silica, Hyrated lime and Cement etc.

Ref: i) Circular No. TM/ID/2362 dated 06.11.2020

ii) Circular No. TM/A/15/48 of 2020-21 dated 31.03.2021

In continuation to this office circulars referred to above, it is observed that during transportation of these cargo, there is leakage on the road near toll naka at Reay Road and road becomes slippery. Port administration have received complaints that two wheelers are skidding due to spillage of chemical powder on the road.

- 2. In view of the above, all Vessel Agents are requested to ensure that jumbo bags containing cargo like PTA, Zeeolite, Magnesium Oxide, Micro Silica, Hyrated lime and Cement etc. brought by their vessel should be in sound condition. Further, it should be ensured that there should not be spillage on wharf and storage area and on roads inside docks.
- 3. Further, it shall be the responsibility of the CHBs/Importers /Transporters to ensure that there should not be any spillage while taking delivery and during transportation inside docks/outside docks to avoid any accident/untoward incidence.
- 4. All Vessel Agents/CHBs/Importers/Transporters are requested to note that non-compliance of the above instructions will lead to stoppage of discharging/delivery of cargo.
