**Sub: Concessional rates for demurrage on  
export of agricultural products (other than sugar)**

To promote export of Agri products (other than Sugar), it has been decided to levy demurrage at concessional rates on export of agri products as under:

- (a) Rs.20.57/- per Tonne per day from 1<sup>st</sup> to 20<sup>th</sup> day as against Rs.77.10 per Tonne per day.
- (b) Rs.52.36/- per Tonne per day from 21<sup>st</sup> to 40<sup>th</sup> day as against Rs.115.62 per Tonne per day, and
- (c) Rs.122.98/- per Tonne per day from 41<sup>st</sup> day onwards as against Rs.154.22 per Tonne per day.

The difference between the rates as per SOR and the concessional rates shall be treated as remitted.

2. Subject concessional rates on demurrage for export of agri products (other than sugar) shall be applicable from 1.11.2019, for a period of one year.

3. All exporters of agricultural commodities and their Associations are requested to avail this facility and route their exports of agri products through Mumbai Port.

4. You are requested to give wide publicity amongst all your members to avail the benefits of the aforesaid concession.
