Sub: Levy of Mandatory User Charge (MUC) on containers towards the Logistics Data Bank (LDB) Service to be rendered by Delhi-Mumbai Industrial Corridor Development Corporation (DMICDC), in the Scale of Rates of all the Major Port Trusts and terminals operating thereat for the year 2019-20, 2020-21 and 2021-22.

Vide circular No. TM/D/1-1/DMICD/11 dated 21.07.2018, it was conveyed that the existing levy approved by TAMP vide order No.TAMP/46/2018-MUC dated 08.06.2018, on containers for the LDB service rendered by DMICDC, is valid till 31.03.2019.

- 2. TAMP has now vide order No.TAMP/46/2018-MUC dated 26.02.2019, extended the validity of the existing tariff (i.e. Rs.145/- per container) for levy of MUC, on containers, for the LDB service rendered by DMICDC, for a period of three months beyond 31.03.2019, i.e. from 01.04.2019 to 30.06.2019 or till the effective date of implementation of new tariff to be fixed for levy of MUC based on the proposal filed by DMICDC, whichever is earlier.
- 3. All are requested to take note of the above and give wide publicity amongst your members.
