**CIRCULAR 15**

Sub. : Preventive measures to be observed in  
Dock premises during cargo handling operations

In one of the recent accidents one Contractor worker fell in dock basin at 15 Indira Dock and was drowned. He was engaged in loading sugar bags in freight containers inside the shed. The victim had no valid reasons to go near wharf edge. Thus avoiding to go near wharf could have avoided the accident.

Cntd. 2..

In order to ensure proper measures for removal of unsafe practices / conditions during cargo handling

- All the employees/ workers should desist from endangering themselves by unnecessarily loitering/ venturing at wharf edge and other danger zones such as Lock Gates, near operation of lifting appliances and transport equipment, ship berthing and unberthing operation, under suspended loads, etc. in the port premises.

You are hereby requested to instruct the contractors and their employees/workers to ensure that the workers take proper safety measures while working in the docks. Non compliance of the same shall be viewed seriously and action as deemed fit, including black listing of the defaulting firm/ company shall be initiated.
