Sub. : Compliance of Safety Norms inside Docks.


In one of the recent accidents, one Contractor worker fell in dock basin at 15 Indira Dock and was drowned. After investigating the accident, it is revealed that said worker had consumed alcohol and therefore under the influence of alcohol fell in the dock basin water.

In order to ensure proper measures for preventing unsafe practices / conditions/accidents during cargo handling operations, it is requested to adhere to the following measure :

***All the employers of dock workers should ensure that none of their worker shall enter the dock premises by consuming alcohol or any drugs. If anyone found, then strict action will be taken against the person and his employer.***

You are hereby requested to instruct the contractors and their employees/workers to strictly comply the above safety measures for making safe atmosphere in the Port.

Non compliance of the above shall be viewed seriously and action as deemed fit, including black listing of the defaulting firm/ company shall be initiated. Further, copy of "Course of Action for drowning" prepared by Safety Cell of MbPA is attached herewith.
