(4) (iii) 1)	Shri Palyekar & Shri.Modak's basic pay was higher since the pay revision of 2007 till the recent revision of 2017. After wage revision of 2017 of Class III & IV employees, your as well as Shri Palyekar and Shri Modak's pay fixation was done in accordance with the wage settlement and finance department's circular no.FA/EWRS-1(2017)/476 1 dt.17.10.2018, which is audited by the Finance Department. In pay fixation, your pay is fixed lesser than your juniors, which is in accordance with wage settlement between Management and workers federation vide this office letter no.FA/EWRS-1(2017)/4701 dt.17.10.2018.
(4) (iii) 2)	Your letter dt.04.12.2018 was referred to the Finance Department for advising on the anomaly in your pay and your juniors, if any. As per their suggestion the case is being referred to the Secretary Department.
(4) (iii) 3)	The required information about Basic pay fixation of Shri Natarajan V.P., Shri Bhandarkar, Shri. Modak, and Shri Palyekar are available in twelve sheets (12 sheets) in this office can be made available to you on payment of Rs. 24/-(Rupees Twenty Four only) as additional fee (i.e.12 x 2/- = Rs.24/-)
