**Sub : Levy of charges on container/containerized  
cargo brought by road from other Ports to  
Mumbai Port for destuffing and delivery.**

In continuation of this office circular No. TM/C/3-93/07 of 88-89 dated 05.05.2018, this is to inform that the facility of free days / charges on the container and containerized cargo brought from other Indian Ports to Mumbai Port by road is extended for a further period of one year from 01.04.2019 or till the commencement of movement of containers from JNPT to MbPT by barges/ships operations, whichever is earlier. The free days/charges will be as under:

(I) **Containers Destuffed in the Port :**

(i) Container:

3 Free days from the date of receipt of the container; licence (storage) fees from the fourth day.

(ii) Containerised Cargo :

5 Free days from the date of receipt of container and demurrage from the sixth day.

(II) **Containers Not Destuffed in the Port and Removed Out of the Port:**

(i) Container:

No Free days. Licence (storage) fees will be levied from the day of receipt of container.


(ii) Containerised Cargo :

3 free days from the date of receipt of container and demurrage from the fourth day.

(III) Rate of charges after the above concessional Free days will be as per SOR approved by TAMP.

(IV) You are requested to give wide publicity amongst all your members to avail the benefits of aforesaid concessions and bring more containers to Mumbai Port.
