Dear Sirs,

Sub: Wharfage rate for Jawahar Dweep 5 (JD5) and indexation thereof.

Oil companies have indicated their need for a new modern jetty to facilitate berthing of fully loaded Suezmax and/or partly loaded VLCC and thereby eliminate and/or minimize the higher ocean freight and other avoidable charges being incurred by them. MbPT after considering the needs of participating Oil Companies (POC) has agreed to commission new modern jetty at JD and invited the POCs to participate in such project on cost sharing basis.


Agreement was entered into on 15.04.2016 amongst Board of Trustees of Port of Mumbai and Bharat Petroleum Corporation Ltd. (BPCL) and Hindustan Petroleum Corporation Ltd. (HPCL) to jointly implement the fifth Oil Berth Project (J5) at JD in Mumbai Harbour and J5 berth has been commissioned on 30.01.2021.

In accordance with Clause 14.3 of agreement between the Board of Trustees of Port of Mumbai and BPCL, HPCL (POC) as regards Fifth Oil Berth Project (J5) at JD in Mumbai Harbour, the wharfage tariff rate is to be adjusted and revised from 1<sup>st</sup> March 2022 by 30% of increase/decrease in Wholesale Price Index (WPI) of previous calendar year as communicated by TAMP or any other empowered authority. In case of third parties / NOCs the rate of wharfage shall be 50% more than the prevailing rate as per this agreement.

Indexed revised wharfage rates for JD5 effective from 01.03.2022 are as under.
