In exercise of the power conferred under Sub-section (1) of Section 27 of the Major Port Authorities Act, 2021, the Board of Mumbai Port Authority vide Board Resolution No.37 has approved in its meeting dated 04.05.2023 the amendment of existing note at Sr.No.1 under General Notes to Section 3. I(B) of SOR by the notes I(a) and (b). Accordingly, Board of Mumbai Port Authority hereby publishes amendment in Sr.No.1 under General Notes to Section 3. I(B) for information of all concerned as required under Clause 4.7 of Tariff Policy, 2021.

The existing note No. 1 under General Notes to Section 3. I(B) of SOR is replaced by the following notes 1 (a) and (b). A statement of existing note of SOR vis-a-vis approved amendment as per BR No.37 dated 04.05.2023 is tabulated below:
