## **CIRCULAR**

## For the information of all MbPA tenants/lessees/licensees.

Estate Division, Mumbai Port Authority has introduced online facility of payment of rent/compensation to all tenants/lessees/licensees w.e.f. 1st April 2020. Since then online payments are being received through online mode such as NEFT, RTGS, Debit Card, IMPS, VAN and UPI. As per our circular dated 31.03.2020, all tenants/lessees/licensees were requested to send their rent/compensation through online mode only due to Covid Pandemic situation and inform their remittance to the Estate Cash Office through e-mail by giving all details of payment such as Bill No., Customer Code, head wise amount paid, date of payment, TDS deducted, GST No., PAN No., UTR No., Transaction ID, Transaction date, etc. for giving proper accounting effect against their respective Customer Record maintained in the Estate Division.

- 2. During the course of reconciliation, it has been observed that some of the tenants/lessees/licensees have remitted their rent/compensation through online mode in the Estate Manager's Bank Account for the period from April,2020 to Jun,2022 but have not forwarded e-mail informing the particulars of their remittance to the Estate Division and consequently payment marking against customer code of tenants/lessees could not be done due to non-availability of payment details of tenants/lessee. This could lead to error in accounting details of the customers toward the recoveries against the respective lettings.
- 3. In the light of above, all tenants/lessees/licensees are requested to inform their payment details as mentioned in the para 1 above (if they have not informed earlier) in the format shown hereunder at the earliest to enable Estate Division to correctly reconcile the dues against their payment.
