## CIRCULAR

> Sub: Revised comprehensive Scale of Rates of Mumbai Port Trust effective from 16.08.2018.

As per Tariff Policy 2015, MbPT Scale of Rates (SOR) were revised with effect from 19.08.2016. In terms of Clause 2.8, 2.9 and 3.2 of Tariff Policy, 2015, the existing SOR will be allowed to be indexed annually to inflation to the extent of 100% of the variation in Wholesale Price Index (WPI) announced by the Government of India occurring between 1st January of previous year and 1st January of the relevant year. Such automatic adjustment of SOR will be allowed subject to the achievement of the performance standards specified in the SOR.

- TAMP vide its letter dated 01.08.2018, has requested the Major Port Trusts 2. to index their Scale of Rates (SOR) by applying an indexation factor of 3.45% for the year 2018-19 subject to achievement of committed Performance Standards during 2017-18. TAMP has further stated that the adjusted SOR will come into force from 01.08.2018 and will be effective till 31.03.2019.
- Accordingly, Section 2.17 of SOR pertaining to Composite Berth Hire Charges and Cargo Related Charges at Section 3.1(A), 3.1(B), 3.1(D), 3.3(A)(I)(II) &(V), 3.3(B), 6.2, 6.3 of SOR for Dry Bulk Cargo only, will stand revised and the new rates (as enclosed) will be effective from 16.08.2018. The revised scale of rates will be published on website "www.mumbaiport.gov.in".
- It may please also be noted that payment of advance deposit and billing towards all charges will have to be made as per the revised rates effective from 16.08.2018.
