(i) The promotional quota after interchanging the quota is 12. Since 4 vacancies were available before the orders of interchanging the ratio they were filled from select list of ATM Gr. I. (ii) Later on the receipt of orders for interchanging the ratio 6 vacancies were filled and one vacancy kept vacant as it is ST point and none of the candidates from select list belong to ST category. (iii) The 02 posts, (One ST post kept vacant as stated at point (ii) and one more vacant post of ATM Gr. I will be filled on holding exam for filling the post of ATM Gr.I on approval Competent Authority.
2	Please state whether existing roasters were followed for awaiting promotions to the post of entry level class-I officer or any new roaster was adopted in any department	The existing roaster is followed for filling the vacancy
