Usage of Port Community System (PCS 1x)

by all Stakeholders

Ref:

Circular No. TM/B-1/10 dated 20.06.2017 and

No. TM/D/1-1/PCS/27 dated 25.11.2019

By referred circular dated 20.06.2017, it was directed to note that -

- All Berthing Applications should be submitted through PCS and it is mandatory.
- The Berthing Applications in PCS shall be submitted after obtaining VCN and only when the Vessel is ready in all respects of cargo handling operations.
- Any Vessel Agent / Shipping Agent applying in PCS for berthing without complying with above norms besides losing seniority of the vessel for berthing, shall be liable for penalty charges for the wrongful declaration or any other action deemed fit by the Port Authority.
- Further, by referred circular dated 25.11.2019, it was informed that in order to 2. implement PCS 1x, IPA and 'Portall' conducted various workshops / training sessions and meetings with stakeholders identified for onboarding PCS 1x, which was made live on 11.12.2018. Given the vast functionally of PCS 1x and improved coverage of stakeholders, it has been decided that usage of PCS 1x for carrying out all trade related electronic document exchange (finance, vessel and cargo) and clearances, is made compulsory for all stakeholders with effect from 16.12.2019. Documents / request specified in PCS 1x shall not be accepted through any mode forthwith.

- 3. In view of above, it has been decided that Berthing Applications shall not be accepted through any mode w.e.f. 10.11.2022. All vessel Agents / Shipping Agents are directed to submit Berthing Applications with full details through PCS only. Berthing Applications received through any other mode like e-mail, hard copy etc will not be accepted and such vessels will not be included in Daily Vessel List and may lose seniority for berthing etc.
