Sub: Certificate under Section 197 of the Income Tax Act, 1961 relating deduction of tax at source at Lower rate for F.Y. 2020-21 – reg.

Ref : This office circular No.TM/B/6-1/TDS/12 of 2020-21 dated July 7, 2020.

Income Tax Authorities have issued Certificates u/s 197 of Income Tax Act, 1961 r.w.s 194A, 194IB, 194C and 194J ibid authorizing Port users, Lessees & Tenants and Banks/ Financial Institutions with TAN mentioned in the certificates to deduct tax at source at lower rate as mentioned below:

Sl. No.	Sections of I.T. Act	Income head	Rate of TDS as per I.T. Act	Lower rate allowed (From August 21, 2020 to March 31, 2021)
1.	194A	Interest other than interest on securities	10%	0.35%
2.	194C	Contractual Income	2%	0.35%
3.	194IB	Rent	10% & 2%	0.35%
4.	194J	Fees for technical Services	10%	0.35%

2. The certificates are valid for the period from August 21, 2020 to March 31, 2021. The certificates are conditional and the lower rate of TDS is applicable on the quantum of income mentioned in Col. 7 of the certificate. Thus, the parties whose names with TAN appear in the certificates have been authorized to deduct the tax at reduced rate allowed by Income Tax Authorities while making payment of various charges to MbPT as per provisions of Income Tax Act, 1961.

3. Hard copies of certificates are available at office of Cash Supervisor (Indira Dock), Deputy Traffic Manager, OSC and Sr. Deputy Traffic Manager, OBL. Soft copies of the certificates are uploaded on the MbPT website www.mumbaiport.gov.in along with the circular.

4. Since the Application process of Lower Deduction certificate is online, the parties can now check their Limits as mentioned in the lower deduction certificate in their Traces site and the rate of tax as per the lower deduction certificate is also reflected on the parties' TRACES site.

5. You are requested to give wide publicity amongst your members.
