Sub: Concessions for Export of all agricultural products
like Sugar, Rice, Soyabean Meal, Wheat, Maize etc.

Ref: This office circular No.TM/A/15-22/45 dt. 23.12.2022.

Vide above referred circular, concessions for export of all agricultural products like sugar, rice, soyabean meal, wheat, maize etc. were granted for a period from 01.01.2023 to 31.12.2023, subject to the terms and conditions as below :-

(i) Slab-wise rebate in stevedoring charges to the exporters for exporting sugar, rice, wheat, maize, soyabean meal etc. during the period 01.01.2023 to 31.12.2023 as under .

- 01 tonne to 24,999 tonnes - 10% rebate
- 25,000 tonnes to 49,999 tonnes - 15% rebate
- 50,000 tonnes and above - 20% rebate


(II) Free days/storage/demurrage as below:

- a) to allow first 30 days free i.e. from Day 1 to Day 30
- b) to levy flat demurrage rate of Rs.60/- per tonne per 15 days for the period 31st day to 45th day
- c) to levy flat demurrage rate of Rs.90/- per tonne per 15 days for the period 46th day to 60th day; thereafter, to levy demurrage charges as section 3.1 (B) of Scale of Rates (SOR) considering 61st day as Day 1.

(III) All sheds in Docks are nominated under abovesaid scheme.

2. In the matter it is to inform that the said scheme will be discontinued from 01.01.2024.

3. It is requested to inform your members of the discontinuation of the above scheme w.e.f 01.01.2024.
