Sub: Parking of vehicles (4 Wheelers/2 Wheelers) at designated places in the Docks

A large number of Vehicles (4 wheelers/2 wheelers) are found to be parked in a haphazard manner inside Docks, which may cause a security issue.

2. Mumbai Port Trust is ISPS Compliant Port and under the requirement of ISPS, the following areas are designated for parking of 4 Wheelers and 2 Wheelers.

# (A) Green Gate I.D.

- (i) Alongside Boundry Wall from Customs Baggage Centre to Grey Gate I.D. for 4 Wheelers
- (ii) Near Container Building adjacent to Fencing of Garden for 2 Wheelers

### (B) Blue Gate/Ambedkar Bhavan

- (i) North side of Blue Gate I.D. for 4 Wheelers
- (ii) South side of Blue Gate I.D. for 2 Wheelers
- (iii)In front of Ambedkar Bhavan Building for 2 Wheelers
- (iv) South side of Ambedkar Bhavan Building for 4 Wheelers

#### (C) New Yellow Gate I.D.

North side of New Yellow Gate I.D. near Customs Baggage Centre for parking of 2 Wheelers

#### (D) Near Hamallage Building

- (i) West side of Hamallage Building for parking of 4 Wheelers
- (ii) Open area in front of the Hamallage Building for parking of 2 Wheelers and 4 Wheelers

Port Users are requested to park their vehicles in Docks at designated places only. In case, any vehicle is found to be parked other than the designated area of parking or parked in the 'No Parking Zone', action as deem fit will be initiated.
