Sub: Facility of berthing and discharging Fertilizer and Fertilizer Raw Materials like Ammonium Sulphate, MOP, MAP, DAP etc. from vessels at BPS / BPX berths and on reducing the draft, shifted to another berth in Indira Dock for continuing the vessel operations.

In view of the demand from the trade, Import vessels with a draft of more than 8.5 mtrs. carrying Fertilizer and Fertilizer Raw Materials such as Ammonium Sulphate, MOP, MAP, DAP etc. will be initially berthed at BPS/BPX and on reducing the draft, shifted to another berth in Indira Dock for continuing the discharging operations.

- The Vessel Agent/ Handling Agent / Receiver shall thoroughly clean and wash the berth after completing the operations.
- 3. Ammonium Sulphate, will be permitted to be stored for a period of 120 days at 12B ID Temporary Shed under the provision of Section 3.3(A)(II) of Chapter III of SOR, at the rate for dry bulk cargo from 31st day to 60th day.

- 4. In the event of arrival of vessels with pulses in these 4 months and if they require the covered storage space at 12B ID Temporary Shed, the Ammonium Sulphate shall have to be shifted from 12B ID temporary shed to MOD temporary sheds B or C.
- 5. Wharfage charges on the entire consignment shall be paid by the Consignee / CHB before completion of discharge of cargo from the Vessel.
- 6. You are requested to give wide publicity amongst your members to avail this facility.
