GULMARG FABRICS & REAL DEAL have made  
structural changes to the building by Excavating  
the floors in both the named shops from 0.76 to  
.0 Metres which has put the Life, Limb & Property  
of the tenants at very high risk & Also the  
encroachment and enclosing done by them of the  
Toilet in the building backside used by servants  
which has been closed from outside and the entry  
to the toilet has been taken inside the shop by the  
name Real Deal belonging to the Landlords.

This has been done without any consideration of the tenants.


