Sub: Concessions for Export of all agricultural products like Sugar, Rice, Soyabean Meal, Wheat, Maize etc.

Ref: Circular No. TM/A/15-22/94 dated 31.12.2021.

By above referred circular dated 31.12.2021, the free days/storage/ demurrage charges for export agri products, were conveyed to trade. Also, information on slab-wise rebate in stevedoring charges in subject matter were informed by abovesaid circular.

- 2. The abovesaid concessions granted have been reviewed and rebate/concessions will be modified as under for agricultural export cargo received / carted in the Port from date of this circular.
 - (i) Rebate in Stevedoring charges will be discontinued.
 - (ii) Concession of 30 free days storage will be continued due to requirement of aggregation of cargo.
 - (iii) Concessional demurrage (storage charges) have been enhanced and same will be as under –

- (a) Flat demurrage rate of Rs.100 per tonne per 15 days for the period 31st day to 45th day.
- (b) Flat demurrage rate of Rs.150 per tonne per 15 days for the period 46th day to 60th day; thereafter, to levy demurrage charges as per Section 3.1 (B) of Scale of Rates considering 61st day as Day 1.
- 3. You are requested to give wide publicity to above, amongst your members.
