Sir,

Your RTI application dated 30.09.2020 received from Shri S.R. Aphale, Dy. Secretary & CPIO, HR Section (GAD), Mumbai Port Trust, vide his letter no. GAD/P/GEE-RTI/Case No.18/2786 dated 06.10.2020, which he received from Ministry of Shipping on 30.09.2020 with reference no. DSHIP/R/E/20/00140, to provide the information sought.

2. Accordingly, assistance of the concerned offices of the Traffic Department have been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

3. On the basis of the information received from the concerned officers of Traffic Department the information / reply pertaining to Traffic Department is as under :

- a. PWD 100 point roaster is maintained with 3 % reservation for PWD in promotions to Group C & D posts in Establishment Section. At Hamallage Section no roaster is maintained as per OM dated 29.12.2005. However, 3% reservation was granted to 03 PWD, in the year 2016 in the recruitment of Tally Clerks.
- b. PWD 100 point roaster is not maintained as per OM dated 15.01.2018.
