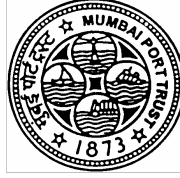

**Sub : Levy of demurrage on vehicles
Imported through Mumbai Port –
Amendment to the Scale of Rates.**

Tariff Authority for Major Ports vide notification No. TAMP/38/2008-MbPT dated 25.01.2010 has approved the proposal of MbPT for levy of demurrage on vehicles imported through Mumbai Port. Accordingly, the existing schedule under section 3.1(B) of Demurrage in the Scale of Rates is replaced as under :

“3.1 (B) Demurrage :

On expiration of free days, save as hereinafter provided, demurrage will be charged for the period of storage on all goods (except mails, post parcels, diplomatic postal bags and personal baggage irrespective of weight per parcel, bag etc.) remaining uncleared at the following rates :

Class of goods	How charged	Rate (Rs.)		
		For first to 20 th day	For 21 st to 40 th day	From 41 st days onwards

(a) In respect of all goods classified in the wharfage schedule in Section 3.1(A) above, other than Motor Vehicles (import).	Per tonne per day or part thereof	37.50	56.25	75.00
(b) Motor Vehicles (Import)	Per vehicle per day	400	1000	2000

NOTE :The personal baggage will be charged at the rate of Rs.15/- per tonne per day or part thereof.”

2. The aforesaid TAMP order has been notified in the Gazette of India Extraordinary (Part III Section 4) on 28.01.2010 vide Gazette No.35 and shall come into effect from 27.02.2010.
