**CIRCULAR**

Sub : Certificate under Section 197 of the Income TAX ACT 1961  
relating deduction of tax at source at Lower rate for F.Y. 2022-23

Ref : FA/AIT/Exemp(2022-23)/2489 dated 24.08.2022.

The Income Tax Authorities have issued Certificates No. 197 of Income Tax Act. 1961 read with section 194A, 194C, 194IB and 194J, ibid authorizing Port users, Lessees & Tenants and Banks/ Financial institutions with TAN Mentioned in the Certificates to deduct tax at source at lower rate as mentioned below :


Sr. No.	Income Head	Section of Income Tax Act	TDS Rate applicable as per I.T. Act.	Lower rate allowed from 15.06.2021 to 31.03.2022
1.	Interest other than interest on securities	194A	10%	0.35%
2.	Contractual income (includes payment by port users for various cargo related & vessel related charges.)	194C	2%	0.35%
3.	Rent	194IB	10% & 2%	0.35%
4.	Fees for technical services	194J	10%	0.35%

2. The certificates are valid for the period from 23.08.2022 to 31.03.2023. The certificates are conditional and the lower rate of TDS is applicable on the quantum of Income mentioned in col. 7 of the certificate. Thus, the parties, whose names with TAN appear in the certificate, have been authorized to deduct the tax at reduced rate allowed by Income Tax Authorities while making payment of various charges to Mb. P.T. as per provisions of Income Tax Act, 1961.

3. Since the Application process of Lower Deduction certificate was online, the parties can now check their Limits as mentioned in the lower deduction certificate in their Traces site and the rate of tax as per the lower deduction certificate is also reflected on the parties traces site.

4. The soft copies of certificate are uploaded on the MbPT website [www.mumbaiport.gov.in](http://www.mumbaiport.gov.in).

5. All concerned are hereby requested to forward the original TDS certificates as usual quoting correct PAN No. & TAN No. of the deductor and the payee, to the Administrative Officer, Marine Billing at Operation Service Center (OSC) on monthly / Quarterly basis, along with the statement showing transaction wise details i.e. VRC / SP. No. and date, Amount of deposit, Tax deducted and deposited.
