

- (ii) Self attested copy of Aadhar Card or any other photo identity card recognized by Government.
- (iii) Payment of MbPT Licence fees.
- (iv) Acceptance of terms and conditions mentioned in Licence Booklet.

4. You are requested to give wide publicity amongst your members to avail of the facility. The last date for submission of application for above all types of Auxiliary Licences will be 06.04.2019. No applications will be accepted thereafter.
