**Sub : Implementation of Indexed SOR effective from 15.05.2023
Under Tariff policy of Major Port Authorities 2021.**

IPA vide letter no. IPA/MSD/WPI/Tariff/2022 dated 27.03.2023 conveyed the indexation factors for port and following factor is applicable to Mumbai Port for Marine Billing

“Automatic annual indexation of SOR as per the clause of 2.8.1 of Tariff Policy for Major Port Authorities 2021 considering 60% of variation in WPI occurring 1st January 2022 and 31st December 2022 is 7.27%.”

2. In view of above, it has, been decided, to enhance Scale of Rates (SOR) of Mumbai Port to the extent allowed by IPA i.e. 7.27% for Marine related charges.
3. It may please be noted that payment of advance deposit and billing towards charges will have to be made as per the revised Indexed Scale of Rates effective from 15.05.2023.
4. Indexed Scale of Rates of Mumbai Port, effective from 15.05.2023 have been uploaded on MBPA official website.
