rate for handling of containers at
CFS/Docks in view of revised Scale of
Rates (SOR) w.e.f. 03.10.2019.**

Vide above referred circular dated 12.03.2019, the Board's approval to the extension of concessional box rate for stuffing and destuffing of containers at Mumbai Port for further period of one year from 30.03.2019 was conveyed. It was informed that rates will be subjected to revision on implementation of revised SOR.

2. Now, in view of implementation of revised Scale of Rates (SOR) w.e.f. 03.10.2019, Board has accorded approval to the revised concessional box rate for stuffing and destuffing of containers at Mumbai Port as under:



Containers having length upto 20'	Rs. 5779	Rs. 6215
Containers having length over 20' and up to 40'	Rs. 11558	Rs.12430
Containers having length over 40'	Rs. 17337	Rs.18645

3. The above revised concessional Box Rate for stuffing and destuffing of containers at Mumbai Port is effective from the date of revised SOR i.e. from 03.10.2019 and is valid upto 30.03.2020.

3. You are requested to give wide publicity amongst all your members to avail the benefits of aforesaid concessions and bring more containers to Mumbai Port.
