Sub: Safety Training to the Drivers and Cleaners of Port users

Ref: Safety Training Programs for "Drivers and Cleaners of Vehicles of Port Users" scheduled during the quarter of January to March 2024.

Safety Training programs for the Drivers and Cleaners of vehicles plying in Mumbai Port area were regularly arranged in recent past at the Port Management Training Centre (PMTTC), MbPA and during the quarter of January 2024 to March 2024 on 23.01.2024, 02.02.2024, 16.02.2024, 01.03.2024 & 28.03.2024.

2. \* Intimation for arrangement of abovesaid programmes were communicated to Transporters and others concerned with a request to send nominations of their Drivers and Cleaners for attending the training programme. The issue was followed up regularly with Shipping Agents, Transporters etc. However, there is no response by the Transporters for deployment of their Drivers / Cleaners for the abovesaid safety training programmes.


3. The abovesaid issue of non-response for training programmes was discussed in a few meetings of Safety Committee of MbPA. The Chairman of Safety Committee had impressed during the said meetings that the Drivers and Cleaners plying the vehicles in Docks should undergo safety training. Also, during the last meeting of Safety Committee for Port of Mumbai held on 7.3.2024, it was again informed that despite arrangement of safety training programme by Safety Cell, there is no response for such training programme from Transporters concerned. Hence, it was directed in the Safety Committee meeting that Dock Entry Permit should be issued to only those Drivers and Cleaners who have undergone safety training.

4. In view of the above, it has been decided that Vehicle Dock Entry Permits will be issued, only to Drivers and Cleaners who have undergone safety training and on submission of Certificate for the same. This will be implemented w.e.f. 1.8.2024.

5. In the meanwhile, it is once again requested to depute your Drivers and Cleaners to the Port Management Training Centre (PMTTC), 2<sup>nd</sup> floor Bhandar Bhavan, Mazgaon (Tel no. 022-66566443) for safety training programme arranged by Safety Cell, MbPA. You may liaise with PMTC (022-66566443) and Safety Cell (Tel. No. 022-66565071, 66565078, 66565067)) for information on schedule of safety training programmes for Drivers and Cleaners.

6. It is requested to give wide publicity to above amongst your members.
