by all Stakeholders.

As a part of Electronic Commerce/Electronic Data Interchange (EC/EDI) for trade, Port Community System (PCS) Project has been implemented to ensure electronic flow of trade related information / document and function as the Centralised Hub for all the Ports of India and provided a common interface facility for all stakeholders.

2. To overcome the difficulties of PCS, PCS 1x has been implemented and made live from 11.12.2018. In order to implement PCS 1x, IPA and "Portall" conducted various workshops/ training sessions and meetings with all stakeholders.

3. The payment made by you to MbPT by NEFT, RTGS, ECS remains unidentified for want of bill reference. The amount so received remains unaccounted and it is not possible for Port to link the same against your outstandings in absence of invoice details.
