Sub: Direction issued by the Central Government under Section 54 of the MPT Act, 1963 to modify the existing demurrage charges/ licence fee for storage facilities of finished Sugar and Pulses at the Major Ports and TAMP's Order No.TAMP/29/2009-Misc. dated 09.11.2010.

Ref: Circular No.TM/D/4-3/21 of 1996-97 dated 24.09.2009.

By this office circular No. TM/D/4-3/21 of 1996-97 dated 24.09.2009, Port users were informed about the Tariff Authority for Major Ports order No.TAMP/29/2009-Misc. dated

22.09.2009, on amended demurrage charges/licence fee in respect of finished Sugar and Pulses other than Yellow Peas.

2. Now, the Govt. of India in the Ministry of Shipping vide its Order No.PT-11033/46/2009-PT dated 01.10.2010 has issued an order in supersession of its earlier order dated 17.9.2009 discontinuing punitive rates of demurrage charges/licence fee in respect of finished Sugar and Pulses other than Yellow Peas under Section 54 of the MPT Act, 1963 with effect from 01.10.2010.

3. Accordingly, TAMP vide order No.TAMP/29/2009-Misc.dated 09.11.2009, has informed to discontinue the punitive rates of demurrage charges/licence fee in respect of Finished Sugar and Pulses other than Yellow Peas with effect from 01.10.2010.

4. Accordingly, the licence (storage) fees on import consignments of Finished Sugar and Pulses will also be charged at par with Raw Sugar and Yellow Peas with effect from 01.10.2010 at the rates as indicated in the circular No.TM/D/4-3/13 of 1996-97 dated 04.08.2010 as under:

(a) License (Storage) Fees on Import consignments of Finished Sugar and Pulses in the specified areas of Port:


Location	Period of storage	Rate per sq.mtr. or part thereof, per month or part thereof. (In Rs.)
Sheds	First 30 days or part thereof	40.00
	31 st day to 180 th day	80.00
Open Yards	First 30 days or part thereof	30.00
	31 st day to 180 th day	60.00

Note: In the event of non-clearance of cargoes within the period of 180 days, demurrage shall be recovered from 181st day onwards under Section 3.1B of Chapter III of Scale of Rates.

5. The above scheme will be valid till 31.7.2011.

6. You are requested to take note of the same and give wide publicity amongst your members.
