

Sub: Nomination of areas at S Plot for storage of Gypsum under Section 3.3(A)(V)(i) of Chapter III of Scale of Rates.

Ref: (i)Circular No.TM/D/4-3/80 dated 11.11.2021. (ii) Circular No.TM/D/4-3/97 dated 07.03.2022.

By Circular dated 11.11.2021, 'S' plot was nominated for storage of Gypsum cargo on recovery of charges under provisions of General Bye Laws. The above notification of 'S' plot is valid for a period of 1 year till 10.11.2022 and was to be reviewed thereafter.

- 2. In the meanwhile, by circular No.TM/D/4-3/97 dated 07.03.2022, approval of Board was conveyed to the Trade as regards extension of the facility of storage of MOP, and other such bulk cargo in outlying area for a period of 180 days. Also for Gypsum cargo, it was conveyed that Board has approved to continue to give further 60 days beyond 180 days (240 days in all). Further, rates applicable were also conveyed. This scheme is valid till 15.03.2023.
- 3. There is a demand from trade for extending the storage facility at 'S' Plot for further period after 10.11.2022.

- 4. In view of above, the nomination of 'S' Plot for storage of Gypsum is further extended for a period of 1 year till 10.11.2023 and will be reviewed thereafter. The storage charges for Gypsum cargo will be levied as per Section 3.3 A (V) (i) of SoR and for the period as provided in abovesaid circular No. TM/D/4-3/97 dated 07.03.2022.
- 5. The storage facility of Gypsum cargo at 'S' Plot will be subject to compliance of measures to control/prevent fugitive dust emission as will be conveyed in permission letter issued by this office.
- 6. You are requested to give wide publicity amongst your members to avail of the above facility.
