Levy of parking charges for open areas being used by transporters for parking of Cargo / Container Handling Equipments engaged in Docks.

Ref: (i) Circular No. TM/A/15-Misc / 19 and TM/M/9-1/11 dated 07.08.2017 and 15.06.2019 respectively. (ii) Circular No.TM/M/9-1/33 dated 30.04.2020

By referred circular No.TM/M/9-1/33 dated 30.04.2020, it was informed that in cases of delay in renewal of Parking Passes for the Cargo/Container Handling Equipments (CHEs), penal charges for the period of delay covered within the lockdown period plus 30 days recovery period will be exempted and only normal charges as per section 9.7 of Scale of rates (SOR) plus taxes will be recovered.

- 2. In view of the request of the Port Users and since the Lockdown period is extended till 30.06.2020, it has been decided that during the Lockdown period from 22.03.2020 till 30.06.2020:-
 - a) Penal charges for delay in renewal of Parking Passes for the Cargo/Container Handling Equipments (CHEs), will be exempted.
 - b) Exemption of 30% will be granted on the parking charges on CHEs stipulated at Section 9.7 of Scale of Rates (SOR) (i.e. parking charges for usage of open area for parking of Cargo/Container Handling Equipment like Mobile Cranes, Forklifts, Reach stackers, JCBs etc. inside the Docks).
- 3. It is requested to inform your members about the same and to arrange to renew the Parking Passes of CHEs on or before 30.06.2020.
