Sub:- Information sought under RTI Act, 2005.

This has reference to your RTI application received in this office on 15.12.2020 Shri A.N. Khatri, Sr. Dy. Material Manager (Estate) & CPIO vide his letter no. EM/218/2024 dated 14.12.2020 which he received from The Shipping Corporation of India Ltd., vide their letter dated 25.11.2020 for furnishing information on your RTI application.

2. Accordingly, assistance of the concerned offices of the Traffic Department have been sought as per the provisions under Section 5(4) of the RTI Act, 2005.

3. On the basis of the information received from the concerned officers of Traffic Department the information / reply is as under :

Sr. No.	Information sought	Information provided
1.	Report copy of the details of lands encroached in Maharashtra.	There are no new encroachments in Port Trust Land under the jurisdiction of Traffic Department. However, old encroachments are existing at few locations since many decades as under: 1. Coal Bunder -693 hutments /encroachments. 2. Lakri Bunder North - 4 hutments /enchroachments. 3. Brick Bunder - 158 hutments / enchroachments. 4. New Tank Bunder - 1500 hutments/enchroachments. 5. Old Sewree Warehouse - 06 hutments/enchroachments. Some areas at Jamshedji Bunder and Old Sewree Warehouse premises are encroached since last 10 years.
2.	Report copy of the steps taken by the Government to evict the encroachments.	In the past, Encroachment Removal Programme has been carried out by Mumbai Port Trust at Bunders and Container Freight Station area. Copies of the same is ready to provide (9 pages).

Report copy of the steps taken to protect the land of Port Trusts.

A mechanism has been set up to ensure continuous monitoring of land under jurisdiction of Port trust by the custodian Department in co-ordination with Chief Security Officer, Mumbai Port Trust in order to avoid any encroachment on Port land as per order dated 30.01.2017 of the Chairman, Mumbai Port Trust. Copy of the same ready to provide (3 pages).

The above stated documents can be provided on payment of additional fees of Rs.24/- (12 pages x Rs.2/- = Rs.24/-).

4. You are, therefore, requested to pay additional fee of **Rs.24/-** at the office of Traffic Manager by Demand Draft/ Pay Order or Postal Order drawn in favour of **'The Board of Trustees of the Port of Mumbai'** and payable at Mumbai, at the earliest.

Alternatively, online payment can be made through NEFT, IMPS or BHIM or UPI in favour of 'The Board of Trustees of the Port of Mumbai', bank account no. 10996685430, State Bank Of India, Mumbai Main Branch, IFSC Code no. SBIN0000300. If, payment made online, it is requested to intimate in writing to this CPIO, about details of the payment such as Date, UTR No./Transaction Reference No., Amount, immediately.

5. In case you are not satisfied with the reply, you may appeal to Smt. S.G. Patwardhan, Sr. Dy. Secretary, MbPT and the First Appellate Authority, 2nd Floor, Port Bhavan, Shoorji Vallabhdas Road, Ballard Estate, Mumbai - 400 001 against the same. Her email ID and contact number is spatwardhan@mbptmail.com and 022-66564047. The period within which appeal could be preferred is 30 days from the date of this communication. The prescribed format of appeal/petition (Annexure D) is enclosed.
