**Sub : Implementation of Revised SOR of MbPT w.e.f. May 01, 2021  
Extension of concessional composite box rate for handling of  
container at CFS/Docks –reg.**

By Circular dated TM/C/3-93/II/45 dated 05.03.2021, the concessional box rate for stuffing/destuffing of containers at Mumbai Port was extended for one more year with effect from 30.03.2021 as under :

2. TAMP vide email dated 20.04.2020 and letter dated 19.03.2021 had informed approval for indexation factor of 1.88% and 0.55% for the years 2020-21 & 2021-22 respectively with regards to revision of Scale of Rates (SOR). Accordingly SOR for cargo related charges was revised w.e.f. 10.04.2021 & 01.05.2021 and the same was informed to trade vide Circulars dated 26.03.2021 & 28.04.2021 respectively.

3. As per above, the concessional composite box rate for stuffing and destuffing of containers at Mumbai Port is revised w.e.f. 10.04.2021 & 01.05.2021 as below :




