## CIRCULAR

The Owners of Pleasure Yachts

**Sub : Storage of pleasure yachts during monsoon period.**

Ref : This office Circular No.TM/B/1-14/10 of 2001-02  
dated June 10, 2019.

In continuation to this office Circular dated June 10, 2019, referred to above and in view of the requests received from Port Users for storage of pleasure yachts during the up-coming monsoon period, this is to inform that the said facility has been extended for the current monsoon period with licence (storage) fee @Rs.1015/- per sq. mtr. per month plus GST. The following three areas are earmarked for storage of pleasure yachts on the ground :

- (i) Hay Bunder
- (ii) Mallet Bunder near Petrol Pump and
- (iii) South of Domestic Cruise Terminal

2. The storage facility at the above places will be granted on "first come first served" basis, subject to the following conditions :

- (a) Permission will be granted to keep the pleasure yachts on the ground at the above mentioned locations on payment of charges of Rs.1015/- per sq.mtr. per month or part thereof in advance for the period of stay requested.

- (b) The area to be billed shall be equal to the area of the yacht i.e. its Length x breadth, plus 25% as the access and working area.
- (c) Dimensions of the boats i.e. length, breadth mentioned in the Registration Certificates shall be the criteria for billing.
- (d) Space will be permitted on "first come first serve" basis, subject to the availability of space.
- (e) Individual owners/their Yacht Agents (who are registered as Shipping Agents in MbPT) would be allowed this service.
- (f) The pleasure yachts shall have to be removed / shifted to alternate location, as and when the area is required by MbPT on 15 days' notice.
- (g) The placement of the pleasure yachts shall not obstruct any Port's activities.
- (h) Repairs and maintenance on request will be allowed simultaneously and necessary temporary bamboo sheds to cover boats for repairs and maintenance shall be permitted against actual occupation, at the above rates. In such cases, the area to be billed will be area occupied by the temporary shed over the yacht + 25% of the area as the access and working area.
- (i) Pleasure yachts will be stored by the owners of yachts at the above mentioned plots at their risks, responsibility, safety precautions, etc.
- (j) Supply of power and water will be provided by Chief Mechanical Engineer and Chief Engineer of MbPT respectively on levy of applicable tariff.
- (k) Permission for keeping private watchman, if sought will be granted on written request by the Owners/Agents of pleasure yachts.
- (l) For repairing, painting and other maintenance, if any, a separate permission shall be obtained by the Owners/Agents of pleasure yachts.
- (m) The Owners of pleasure yachts should indemnify Mumbai Port Trust against any mishap, accident, damage to the pleasure yachts and MbPT property and injury to persons working thereat and the MbPT personnel.
- (n) On completion of the allotted period, the pleasure yachts shall be removed and peaceful vacant possession shall be given to MbPT.
- (o) The Owner/Agents desirous of availing the facility should make application to the Traffic Manager, MbPT on their letter head in the enclosed format.

4. You are requested to give wide publicity amongst your members to avail the said facility.
