Sub: Nomination of areas under General Bye Laws for storage of dry bulk cargo and erection of temporary shed.

Ref: TM/D/4-3/20 of 2017-18 dated 22.09.2017 TM/D/4-3/23 of 1995-96 dated 22.08.2012

Vide referred circular dated 22.09.2017, an open area admeasuring 10,000 sq. mtrs. at Golden Yard (Wadala) was notified for storage of import Gypsum under General Bye Laws.

2. In view of demand of the trade, the entire open area of Golden Yard (Wadala) is notified for storage of all dry bulk cargo cleared from Docks/ Bunders on recovery of charges under General Bye Laws (GBL) as under:

- 3. Vide referred circular dated 22.08.2012, certain open areas in outlying areas were notified/specified for erection of temporary sheds by the users at their own risk and cost for storage of cargo/cargo management activities under provisions of Section 3.3 (A)(II) and (III) of SOR.
- 4. Further, in view of demand of trade, the entire open area of Golden Yard (Wadala) is also notified for erection of temporary sheds for storage of all dry bulk cargo cleared from Docks / Bunders on recovery of charges under GBL / Cargo management activities. Other provisions of the referred circular dated 22.08.2012 remain the same.
