Dear Sirs,

Sub : Erratic Parking of Cars and Motorcycles near Dock Gates.

Of late, many private cars are seen parked near Green Gate ID (GG ID) and all along the surrounding areas haphazardly & blocking the passage towards Green gate. This creates a nuisance for smooth flow of traffic & also cause of possible security hazards at Green Gate, Indira Dock. The parking in Docks is a facility for very limited hours to facilitate the bonafide work, inside the docks. It is seen that cars/mobikes are parked day long and most of the vehicle owners work outside the docks.

2. The vehicles parked near GG ID and surrounding areas are of Port officers/staff, Navy Officers/staff, Customs officers/staff and Port Users.

3. To have a proper control, ensure safety & security and regulation, the parking of four/two wheeler vehicles and keeping in view the availability of limited parking space in Docks, following parking areas are designated for parking of four wheelers/two wheelers.



4. Parking slots are marked at above designated areas and "NO PARKING" boards are displayed in the Docks. Four wheelers/two wheelers parked in other than above designated areas inside Docks shall be clamped and penalty of Rs.2500/- will be levied.

5. All concerned are requested to ensure parking of their vehicles in Docks at designated places only. In case, any vehicle is found to be parked in area other than the designated area of parking or parked in the "No Parking Zone", a penalty of Rs.2500/- will be levied.

6. The Circular will be effective from 20.09.2021.
