and as per available record, same is provided, as under :-



Consignee of consignment of 380 bags, Rock Salt covered under IGM /Item No. 3363/58 dated 30.12.1987 m.v. A/Star is M/s Special International Travels N. Commerce. The Vessel Agent for the said vessel was M/s Killick Nixon Ltd.

3.	Description and value of the goods imported.	Description of consignment covered under IGM /Item No. 3363/58 dated 30.12.1987, Vessel : m.v. A/Star is 380 Bags, Rock Salt, Manifested Weight = 143060 kgs. Value of the goods is not available.

The NOC for disposal of said cargo was received from the customs in February 2014. On receipt of NOC, the cargo was put up for auction sale during 24.03.2014 to 06.02.2017 on 13 occasions. After follow-up with ADC/FSSAI, reply dated 31.01.2017 was received. In view of letter dated 30.01.2017 of FASSAI, the destruction of lot has been completed on 17.07.2018.
