for F.Y. 2019-20 – reg.**


Ref : This office circular No.TM/B/6-1/TDS/07 of 2019-20  
dated May 27, 2019.

In continuation of the above circular, as per CBDT notification dated 31.03.2020 extending the validity of Lower or Nil Tax Deduction / Collection Certificate for FY 2019-20 it has been stated that Assessors who are holding a

valid LOWER OR NIL TAX DEDUCTION / COLLECTION CERTIFICATE for FY 2019 - 20 but could not apply for a new one for FY 2020-21 on the TRACES portal can continue using the Lower Deduction Certificate for FY 2019-20 till 30<sup>th</sup> June 2020.

2. The Lower deduction certificate which was applicable last year stands valid till June 30, 2020 for all the parties mentioned in the certificate. The rate of TDS as per the certificate is 0.35%.
3. Soft copies of the certificates are uploaded on the MbPT website [www.mumbaiport.gov.in](http://www.mumbaiport.gov.in) along with the circular.
4. You are requested to give wide publicity amongst your members.
