

**Sub: Storage facilities for Project Cargo and
Machineries at Mumbai Port.**


As per the demand from trade, the Project cargoes and Machineries imported through MbPT will be permitted storage upto 180 days at nominated sites / areas / plots in outlying areas on recovery of charges specified under Section 3.3(A)(II) of SOR and GBL, as applicable.

2. In the event of non-clearance of the consignments within the period of 180 days, demurrage shall be recovered from 181st day onwards at the rates specified in Section 3.1 (B) of Chapter III of the Scale of Rates, subject to revision / modification from time to time. For the storage areas covered under GBL, charges @Rs.20 per sq.mtr. per day will be leviable from 181st day onwards, subject to revision / modification from time to time.
3. Initially 'B' Plot at Cotton Depot is nominated as storage facility for Project cargo and Machineries.
4. This facility is valid for a period of 1 year from 06.12.2021.
5. You are requested to give wide publicity amongst your members to avail this facility and bring more machineries and Project cargoes to the Port.
