CIRCULAR

The Owners of Pleasure Yachts
President, MANSAA,
President, BCHAA

Sub : Storage of pleasure yachts during monsoon period.

Sir,

Several requests have been received from the owners of the pleasure yachts for storage on the ground during monsoon period. Following 4 locations have identified for storage on the ground :

- (i) Open area at MbPT Workshop;
- (ii) Triangular plot on the south of Nirman Bhavan;
- (iii) Kerosene Wharf on the east of Sewree Timber Pond; and
- (iv) Open area of 3000 sq.mtrs. at Hay Bunder.

2. The facility will be granted on a first come first served basis subject to following conditions :

- (a) Permissions will be granted to keep the pleasure yachts on the ground at the above mentioned locations on payment of charges of **Rs.222.50 per sq.mtrs. per month or part thereof** in advance. The charges will be levied for minimum area of 100 sq.mtrs. In case, if any yacht occupying more than 100 sq.mtrs., charges for a minimum of 200 sq.mtrs. shall be recovered.
- (b) Pleasure yachts will be stored by the owners at the abovementioned plots at their risks and consequences. Permission for keeping private watchmen, if sought, will be given on written requests by the owners of pleasure yachts.

- (c) For repairing, painting and other maintenance, if any, separate permission should be obtained.
- (d) The owners of pleasure yachts should indemnify Mumbai Port Trust against any mishap, accident, damage to the pleasure yachts and MbPT property and injury to persons working thereat or the MbPT personnel.
- (e) On completion of the allotted period, the pleasure yachts shall be removed and peaceful vacant possession should be given to MbPT.
- (f) The owner desirous of availing the facility should make application to the Traffic Manager, MbPT on their letterhead in the enclosed format.

2. The new charges will be levied from the date of issuance of the circular on the yachts already stored on the ground.
