Sub: **Concessions for Export of all agricultural products like Sugar, Rice, Soyabean Meal, Wheat, Maize etc.**

Ref : **Circular No. TM/A/15-22/35 & 43 dated 04.01.2021 & 04.03.2021 respectively.**

Mumbai Port is keen to attract export of agri products and has revamped its facilities attracting export of sugar in large quantities. With a view to encourage export of more agri products like sugar, rice, soyabean meals, maize, wheat etc. through Mumbai Port, an attractive scheme aiming at reduction of cost in Mumbai Port was conveyed to trade by referred circulars dated 04.01.2021 & 04.03.2021. In continuation to circulars under reference, the abovesaid scheme for agri products like Sugar, Rice, Soyabean Meal, Wheat, Maize etc., is being further extended with terms and conditions as below :-

- (I) Free days/storage/demurrage as below:
- to allow first 30 days free i.e. from Day 1 to Day 30;
  - to levy flat demurrage rate of Rs.50/- per tonne per 15 days for the period 31<sup>st</sup> day to 45<sup>th</sup> day;
  - to levy flat demurrage rate of Rs.75/- per tonne per 15 days for the period 46<sup>st</sup> day to 60<sup>th</sup> day; thereafter, to levy demurrage charges as per section 3.1 (B) of Scale of Rates (SOR) considering 61<sup>st</sup> day as Day 1.



(II) Slab-wise rebate in stevedoring charges to the exporters for exporting sugar, rice, wheat, maize, soyabean meal etc. during the period 01.01.2022 to 31.12.2022 as under :


- 01 tonne to 24,999 tonnes – 10% rebate
- 25,000 tonnes to 49,999 tonnes – 15% rebate
- 50,000 tonnes and above – 20% rebate

2. The above rates shall be applicable for a period of one year from 01.01.2022 to 31.12.2022 and shall be reviewed thereafter. For the above facility, all sheds inside Docks (including 12B ID Temporary shed) and outlying areas are notified as Pre-shipment storage area for export of agricultural products like sugar, rice, soyabean meal, maize, wheat etc.

3. All exporters of agricultural products like sugar, rice, soyabean meal, maize, wheat etc. are requested to avail the above facility and route their exports of these cargoes through Mumbai Port.

4. You are requested to give wide publicity amongst all your members to avail the benefits of the aforesaid concession.
