of Gypsum and fertilizers viz Ammonium Sulphate,
MOP, MAP, DAP etc. under Section 3.3(A)(II) of
Chapter III of Scale of Rates.



By Circular dated 17.03.2012, open area admeasuring approx. 10000
sq. mtrs. at Haji Bunder, Opposite Fire Brigade Station has been notified for
storage of import cargo, under provisions of Section 3.3(A)(II) of Chapter III of
Scale Of Rates.

2. By Circulars dated 21.01.2015 and 29.12.2016, Compartment Nos. 1
and 2 of 'C' Shed Haji Bunder were nominated for storage of import pulses
under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

3. By Circular dated 11.02.2016, Compartment Nos. 1 and 2 of 'C' Shed Haji Bunder were nominated for storage of cement cleared from Docks, under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.
4. By Circular dated 28.03.2018, 'C' Shed, Haji Bunder was nominated for storage of silica sand in addition to pulses and cement, under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.
5. In view of demand of the trade, entire open area of Haji Bunder and covered area of 'C' Shed, Haji Bunder are notified with immediate effect for storage of import Gypsum and fertilizers viz. Ammonium Sulphate, MOP, MAP, DAP etc., cleared from Docks/ Bunders or landed at Haji Bunder, in addition to pulses, cement and Silica Sand, on recovery of charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates, for a period upto a maximum of 60 days.
6. The storage will be permitted on monthly basis (30 days) on the request of Importers/CHBs on 'First come first serve basis'.
7. You are requested to give wide publicity amongst your members to avail of the facility.
