CIRCULAR

Sub: Engaging Retired MbPT Employees

Large quantity of uncleared / unclaimed cargo lying at New Sewree Ware House, New Frere Basin Ware House and 5 Ware House Prince's Docks has been taken for disposal through one-time-e-Tender-cum-e-Auction.


2. Considering the reduction in the number of staff due to retirement, the work of conducting inventory, valuation, follow up with Customs, etc require additional manpower which is proposed to be met by engaging retired employees from the category of Shed Supdt. / Valuer / Asstt. Shed Supdt., who have retired on or after 01.01.2020.

The applications should reach to Establishment Branch, Traffic Department on or before 01.04.2022.

3. The terms and conditions for engaging retired staff members on purely contract basis as approved by Competent Authority are as under.

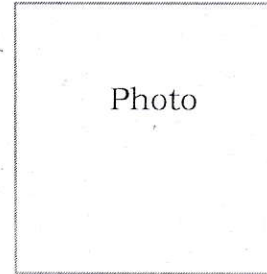
- i) Retired employees of Traffic Department from the category of Shed Supdt., Valuer and Asstt. Shed Supdt., shall only be considered.
- ii) The retired employees should have retired on or after 01.01.2020.
- iii) They shall be deployed on contract basis for a period of 3 months, extendable by one term of 3 months.
- iv) The retired employees shall have experience of working in warehouses / sheds.
- v) The remuneration to be given to the Ex-Asstt. Shed Supdt and Ex. Shed Supdt. / Valuer will be Rs. 22,000/- and Rs. 25,000/- p.m. respectively. The duty hours will be from 8:00 am to 5:00 pm with one hour recess with weekly off on Sunday. Casual Leave of 3 days will be given for 03 months.

- vi) 24 persons will be engaged for a period of 3 months for carrying out the work of inventory / valuation, documentation, custom procedure etc.
