Sirs,

Sub: Grant of 6 free days following the date of Vessel Completing Discharging (VCD) for Rashtriya Chemicals & Fertilizers Ltd. (RCF Ltd.)'s cargo discharged in stream and brought by the barges at Hay Bunder in line with cargo discharged in stream and brought by barges in Indira Docks.

Mother vessels brings large volumes of import dry bulk cargo such as fertilizer/fertilizer raw material etc. to discharge at PLA or at inner anchorage into the barges. The barges are subsequently brought to Hay Bunder / Haji Bunder for discharging on wharf or into the dumpers for direct delivery and transfer to nominated storage areas.

2. All concerned are requested to note of computing the Vessel Completion Date (VCD) and grant of free days in respect of operations at Hay Bunder / Haji Bunder will be as under:-

- i) Vessel Completion Date (VCD) for the vessel discharging cargo in midstream and subsequently, bringing such cargo at Hay Bunder / Haji Bunder by barges, shall be the date following two days after the date of completion of discharging of mother vessel in stream;

- ii) The cargo discharged in midstream and brought to Hay Bunder / Haji Bunder shall be allowed six days free following the date of completion of discharging of mother vessel (VCD); whereafter, demurrage shall be levied as per Scale of Rates as applicable.

3. On completion of discharging operations of mother vessels, the Vessel Agent shall inform immediately the offices of (i) Sr. Dy. Traffic Manager, Operation - Outlying Areas (email : dmcfs@mbptmail.com), (ii) Traffic Manager (email : tm@mumbaiport.gov.in) and (iii) Sr. Asstt. Traffic Manager, Traffic Manager's office (email : tmoffice@mbptmail.com), the details of cargo brought, discharged, date & time of commencement/completion of discharging operation etc. and submit Vessel Completion Certificate, duly certified by the Chief Officer of the mother ship.

4. The above procedure shall be put into place with immediate effect.

5. The existing facility of free period of 15 days from the date of discharge of first barge from mother vessel as communicated to trade vide circular No.TM/B/1-13/9 of 2003-04 dated 19.05.2007 stand discontinued.

6. You are requested to inform your members suitably.
