



Validation of duty levied and collected.

"9. (1) Notwithstanding anything contained in any judgement, decree or order of any court to the contrary or in the Stamp Act, stamp duty assessed, levied and collected including any action taken in pursuance of such assessment, levy and collection by the authorities under the said Act, acting or purporating to act under the provisions of article 25 in the Schedule I to the Stamp Act shall be deemed to have been validly levied and collected in accordance with law as if the provision of the said article 25, Mah. as amended by the Maharashtra Tax Laws (Levy, Amendment and Validation) Act, XXX 1997, had been continuously in force at all material time and accordingly:-

(a) all actions, proceedings or things done or taken by the authorities under the 1997. Stamp Act in, connection with the levy and collection of the stamp duty shall, for all purposes, be deemed to have been done or taken in accordance with the provisions of the said Act;

- (b) no suit or other proceedings shall be maintainable or continued in any court, against the said authorities for the refund of the stamp duty so levied and collected;
- (c) no court or any other authority shall enforce any decree or order directing the refund of the stamp duty so levied or collected.
- (2) For the removal of doubt, it is hereby declared that nothing in sub-section (1) shall be construed as preventing a person,-
  - (a) from questioning in accordance with the provisions of the Stamp Act, as amended by this Amendment Act, any assessment, re-assessment, levy or collection of stamp duty referred to in sub-section (1), or
  - (b) from claiming refund to any stamp duty paid by him under the Stamp Act, in excess of the amount due from him by way of stamp duty under the said Act, as amended by this Amendment Act."

# An Act to consolidate and amend the law relating to stamps and stamp duties in the State of Bombay.

WHEREAS it is expendient to consolidate and amend the law relating to stamps and rates of stamp duties other than those in respect of document specified in entry 91 of List I in the Seventh Schedule to the Constitution of India in the State of Bombay; It is hereby enacted in the Ninth Year of the Republic of India as follows:—

## CHAPTER I

## PRELIMINARY

- 1. (1) This Act may be called the Bombay Stamp Act, 1958.
- Short title, extent and commencement.
- (2) It extent to the whole of the <sup>1</sup>[State of Maharashtra].
- (3) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, direct.
- 2. In this Act, unless there is anything repugnant in the subject Definitions. or context,—
- (a) "association" means any association, exchange, organisation or body of individuals, whether incorporated or not, established for the purpose of regulating and controlling business of the sale or purchase of, or other transactions relating to, any goods of marketable securities;
- <sup>2</sup>[(b) "banker" means an association, a company or a person who accepts for the purpose of lending or investment, deposits of money from the public, re-payment on demand or otherwise and withdrawable by cheque, draft, order or otherwise;]
  - (c) "bond" includes,--
  - (i) any intrument whereby a person obliges himself to pay money to another on condition that obligation shall be void if a specified act is performed, or is not performed, as the case may be;
  - (ii) any instrument attested by a witness and not payable to order or bearer whereby a person obliges himself to pay money to another; and
  - (iii) any instrument so attested whereby a person obliges himself to deliver grain or other agricultural produce to another;

instrument, or has seen some other person sign the instrument in the presence and by the direction of the executant, or has received from the executant a personal acknowledgement of his signature or mark or of the signature of such other person, and each of whom has signed the instrument in the presence of the executant; but it shall not be necessary that more than one of such witnesses shall have been present at the same time, and no particular form of attestation shall be necessary);

(d) "chargeable" means, as applied to an instrument, executed or first executed after the commencement of this Act, chargeable under this Act, and as applied to any other instruments, chargeable under the law in force in the State when such instrument was executed or, where several persons executed the instrument at different times, first executed;

Chief Officer in charge of the revenue administration of a district and includes any officer whom the State Government may, by notification in the Official Gazette, appoint in this behalf 5 and on whom any or all the powers of the Collector under this Act are conferred by the same notification or any other like notification.]

- (h) "duly stamped" as applied to an instrument means that the instrument bears an adhesive or impressed stamp of not less than the proper amount and that such stamp has been affixed or used in accordance with the law for the time being in force in the State;
- (i) "executed" and "execution" used with reference to instruments mean "signed" and "signature";

- (j) "Government secutivies" means a Government security as defined in the Public Debt Act, 1944;

  - (ii) a Kabulayat, or other undertaking in writing not being a counterpart of a lease to cultivate, occupay or pay or deliver rent for immoveable
    - (iii) any instrument by which tolls of any description are let;
  - (iv) any writing on an application for a lease intended to signify that the application is granted;

 $\mathfrak{1}[(v)]$  a decree or final order of any Civil Court in respect of alease:

Provided that, where subsequently an instrument of lease is executed in pursuance of such decree or order, the stamp duty, if any, already paid and recovered on such decree or order shall be adjusted towards the total duty leviable on such instrument;

- (p) "mortgage deed" includes every instrument whereby, for the purpose of securing money advanced, or to be advanced, by way of loan, or an existing or future debt, or the performance of an engagement, one person transfers or creates to, or in favour of another, a right over or in respect of specified property;

- (r) "power of attorney" includes any instrument (not chargeable with a fee under the law relating to court-fees for the time being in force) empowering a specified person to act for and in the name of the person executing it <sup>6</sup>[and includes an instrument by which a person, not being a person who is a legal practitioner, is authorised to appear on behalf of any party in any proceeding before any court, Tribunal or authority];

  - (s) "Schedule" means a Schedule appended to this Act;
- (t) "settlement" means any non-testamentory disposition in writing of movable or immovable property made

  - (ii) for the purpose of distributing property of the settler among his family or those for whom he desires to provide, or for the purpose of providing for some person dependent on him, or
  - (iii) for any religious or charitable purpose, and includes an agreement in writing to make such a disposition and where any such disposition has not been made in writing any instrument recording whether by way of declaration of trust or otherwise, the terms of any such disposition;
- (u) "soldier" includes any person below the rank of a non-commissioned XLVI officer who is enrolled under the Army Act, 1950.

# CHAPTER II

#### STAMP DUTIES

# (A)—Of the Liability Of Instruments to Duty

Subject to the provisions of this Act and the exemptions Instrument contained in Schedule I, the following instruments shall be chargeable chargeable with duty of the amount indicated in Schedule I as the proper duty therefor respectively, that is to say—

- (a) every instrument mentioned in Schedule I, which, not having been previously executed by any person, is executed in the State on or after the date of commencement of this Act;
- (b) every instrument mentioned in Schedule I, which, not having been previously executed by any person, is executed out of the State on or after the said date, relates to any property situate, or to any matter or thing done or to be done in this State and is received in this State:

- (1) any instrument executed by or on behalf of, or in favour of, the Government in cases where, but for this exemption, the Government would be liable to pay the duty chargeable in respect of such instrument <sup>3</sup> or where the Government has undertaken to bear the expenses towards the paymnet of the duty.]
- (2) Any instrument for the sale, transfer or other disposition, either absolutely or by way of mortgage or otherwise of any ship or vessel, or any part, interest, share or property of or in any ship or vessel registered under the Bombay Coasting Vessels Act, 1838, or 4 Merchant Shippinng Act, 1958].
- 4. (1) Where, in the case of any sale, mortgage or settlement, several Several instruments are employed for completing the transaction, the principal instruments instrument only shall be chargeable with the duty prescribed in Schedule single I for the conveyance, mortgage or settlement, and each of the other transaction instrument shall be chargeable with a duty of <sup>5</sup>[one hundred rupees] instead of the duty (if any) prescribed for it in that Schedule.

- (2) The parties may determine for themselves which of the instruments so employed shall, for the purposes of sub-section (1), be deemed to be the principal instrument.

Provided that the duty chargeable on the instrument so determined shall be the highest duty which would be chargeable in respect of any of the said instruments employed.

Provided that any Court before which any such instrument, duplicate or copy is produced may permit the duty chargeable under this section to be paid theron and may then receive it in evidence:

- (3) In the case of wilful neglect to pay the duty required by this section the local authority shall be liable to forfeit to the State Government a sum equal to ten per centum upon the amount of duty payable, and alike penalty for every month after the first month during which such neglect continues.



- 12. (1)(a) Whoever affixes any adhesive stamp to any instrument chargeable Cancellation with duty which has been executed by any person shall, when affixing such stamps of adhesive cancel the same so that it cannot be used again; and



- (b) and in addition to the stamps, if any, already affixed thereto such instrument <sup>1</sup>[or a copy of such instrument] shall be stamped with the stamps necessary for the payment of the duty chargeable on it under clause (a) of this section, in the same manner and at the same time and by the same persons as though such instrument 1 [or a copy of such instrument] were an instrument received in this State for the first time at the time when it became chargeable with the higher duty, and



- (2) Where property contracted to be purchased for one consideration for the whole, by two or more persons jointly, or by any person for himself and others, or wholly for others, is conveyed in parts by separate instruments to the persons by or for whom the same was purchased, for distinct parts of the consideration, the conveyance of each separate part shall be chargeable with ad valorem duty in respect of the distinct part <sup>1</sup>[in respect of the market value of such part of the property.]



### CHAPTER V 35

## ALLOWANCES FOR STAMPS IN CERTAIN CASES

- 47. Subject to such rules as may be made by the State Government as to the Allowance evidence to be required or the inquiry to be made, the Collector may on application for spoiled made within the period prescribed in section 48, and if he is satisfied as to the facts stamps make allowance for impressed stamps spoiled in the cases bereinafter mentioned namely:—
  - (a) the stamp on any paper in advertently and undesignedly spoiled, obliterated or by error in writing or any other means rendered unfit for the purpose intended before any instrument written thereon is executed by any person;
  - (b) the stamp on any document which is written out wholly or in part, but which is not signed or executed by any party thereto;
    - (c) the stamp used for an instrument executed by any party thereto which—
    - (1) has been afterwards found 1[by the party] to be absolutely void in law from the beginning;
    - <sup>2</sup>[(1A) has been afterwards found by the Court, to be absolutely void from the beginning under section 31 of the Specific Relief Act, 1963;]
    - (2) has been afterwards found unfit, by reason of any error or mistake therein for the purpose originally intended;
    - (3) by reason of the death of any person by whom it is necessary that it should be executed, without having executed the same, or of the refusal of any such person to execute the same, cannot be completed so as to effect the intended in transaction the form proposed;
    - (4) for want of the execution thereof by some material party, and his inability or refusal to sign the same, is in fact incomplete and insufficient for the purpose for which it was intended;
    - (5) by reason of the refusal of any person to act under the same, or to advance any money intended to be thereby secured, or by the refusal or non-acceptance of any office thereby granted, totally fails of the intended purpose;
    - (6) becomes useless in consequence of the transaction intended to be thereby effected by some other instrument between the same parties and bearing a stamp of not less value;
    - (7) is deficient in value and the transaction intended to be thereby effected had been effected by some other instrument between the same parties and bearing a stamp of not less value;
    - (8) is inadvertently and undesignedly spoiled, and in lieu whereof another instrument made between the same parties and for the same purpose is executed and duly stamped:

Provided that, in the case of an executed instrument, <sup>3</sup>[except that falling under sub-clause (1A)], no legal proceeding has been commenced in which the instrument could or would have been given or offered in evidence and that the instrument is given up <sup>4</sup>[to be cancelled, or has been already given up to the Court to be cancelled.]
