Sub : Nomination of area for storage of Ammonium Sulphate under Section 3.3(A)(II) of Chapter III of Scale of Rates.

Ref : Circular Nos. TM/D/4-3/41, 36, 29 and 33 dated 21.03.2018, 26.02.2019, 03.12.2019 and 27.12.2019 respectively.


By a Circular dated 21.03.2018, Temporary Sheds A, B and C (area admeasuring 12,000 sq. mtrs. approx.) at MOD were notified for storage of import Gypsum under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

2. By Circular dated 26.02.2019, Temporary Sheds 'A', 'B' and 'C' at MOD Open Yard (area admeasuring 12000 sq. mtrs. approximately) were nominated for storage of MOP cleared from Docks / Bunders, in addition to pulses, Gypsum and Silica Sand (Temp Shed 'C') on recovery of charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

3. By Circular dated 03.12.2019, Temporary Shed C (area admeasuring 4700 sq. mtrs. approx.) at MOD was notified for storage of Ammonium Sulphate, cleared from Docks / Bunders, in addition to pulses, Gypsum and Silica Sand, under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.

4. By Circular dated 27.12.2019, Temporary Shed B (area admeasuring 3400 sq. mtrs. approx.) at MOD open yard was notified for storage of Ammonium Sulphate, cleared from Docks / Bunders, in addition to Pulses, MOP and Gypsum, under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.
5. In view of demand of the trade, Temporary Shed 'A' at MOD Open Yard (area admeasuring 3472 sq. mtrs. approximately) is notified for storage of Ammonium Sulphate cleared from Docks/ Bunders, in addition to Pulses, MOP and Gypsum, on recovery of charges under provisions of Section 3.3(A)(II) of Chapter III of Scale of Rates.
6. You are requested to give wide publicity amongst your members to avail of the facility.
