Sub : Supply of Information under the RTI Act,2005.

Ref: Your RTI Application dated 27.11.2018
received on 10.12.2018.

With reference to the above subject, you are hereby informed that the information sought by you at Sr. No. 3 of your application, cannot be provided as per the provisions under Section 8 (1)(g) of the RTI Act (as quoted in para 2 below) for the following reasons:

- i) Police Inspector, Nehru Nagar Police Station vide his letter dated 22.10.2012 had informed that you had stabbed Shri Shyam Shridhar Parab on 05.10.2011 and also locked him in Pumproom with a motive to kill him.
- ii) You had therefore, been convicted by the Bombay Sessions Court for Greater Mumbai vide its order dated 30.04.2012 under Section 235 of Cr.P.C. for offences punishable under Section 307 (Attempt to Murder), 342 (Punishment for assault or criminal force otherwise than a grave provocation) of IPC and you were sentenced to rigorous imprisonment for 10 years and ⁱⁿ fine of Rs.10,000/- and a default to pay fine, simple imprisonment of one more year.
- iii) You had also violently entered the cabin of Officer of MEED, Mb.P.T. and threatened her on 04.10.2011 which was witnessed by the MEED Officers and staff.
- iv) Considering your above mentioned behavioural history, it is felt that providing the information sought in your application may endanger the life or physical safety of MbPT official/s or identify the source of information or assistance given in confidence for law enforcement or security of MbPT officials.

2. Section 8(1) (g) of RTI Act, 2005 states that :

Quote

"8(1) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen, -

- g) information, the disclosure of which would endanger the life or physical safety of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes;"

3. If you are aggrieved by the above reply, you may file an appeal before the Appellate Authority in the prescribed format (copy enclosed) within 30 days from the date thereof. Please note that, Sr. Deputy Secretary, GAD, MbPT, Secretary's Office, Port House, 2nd Floor, S.V. Marg, Mumbai-400 001(Contact No. 66564061, Email Id-secretary@mbpt.com) is the First Appellate Authority under the Act for MbPT.
