Contractors for Civil Engineering Works
for the cycle 2019-2023**

Online/Offline Applications are invited from the experienced Civil Engineering Works Contractors for empanelment in the registered list of contractors for works costing up to Rs. One crore. Contractors will be registered in Class A to D and specialty I to VII depending upon their financial and technical capabilities. Desirous firms can apply for registration online at www.mumbaiport.gov.in and follow the instructions at the website. For any doubts/clarifications, the firms can contact Tel.No.022-66564558.

2. Online Registration is under implementation at www.mumbaiport.gov.in and will commence soon. Till the online registration is fully operational, Registration can be applied offline by downloading the Application Form and Rules of Registration from the Mumbai Port Trust website. The filled in application with relevant documents will be received at Mumbai Port Trust, Civil Engineering Department, Accounts Section, Vijay Deep, 4th Floor, Shoorji Vallabhdas Marg, Fort, Ballard Estate, Mumbai 400001, Tel.No.022-66564558. Desirous firms applying for registration will have to make payment of Rs.2,100/- (Rupees Two Thousand One Hundred) only inclusive of 5% GST towards Cost of Application and Rs.23,600/- (Rupees Twenty Three Thousand Six Hundred) only inclusive of 18% GST towards Scrutiny Fees for Registration in the form of Pay Order/Demand Draft drawn in favour of "The Board of Trustees of the Port of Mumbai" payable at Mumbai. The Application and Scrutiny Fees are non-refundable.
3. After the commencement of online registration at the website, the offline registration will be stopped and the desirous firms will have to apply online at the website. The cost of Application for the registration will be payable online at www.mumbaiport.gov.in as per the directions at the website.
4. After preliminary examination of the papers submitted online by the applicant firm, the firm will be required to pay the Scrutiny Fee online at www.mumbaiport.gov.in
5. The Application and Scrutiny Fees are non-refundable.

6. The contractors can make application for registration at any point of time during the registration cycle upto 30th June 2023 or extension thereof. The registration, once done on merits in response to this notification, will be valid maximum until 30th June 2023 or extension thereof.

7. The contractors will be registered in 4 classes and 7 specialties as detailed below depending upon their financial and technical capabilities.

Class A	upto and including Rs. 100 lakh
Class B	upto and including Rs. 60 lakh
Class C	upto and including Rs. 30 lakh
Class D	upto and including Rs. 10 lakh

Speciality III -	Restorative Repairs
Speciality IV -	Buildings, Godowns, Warehouses and Shed
Speciality V -	Other Civil Engineering works
Speciality VI -	Labour intensive works
Speciality VII -	Permanent Way works

The works costing upto Rs.25.00 lakhs will be invited online from Registered contractors only and works costing above Rs.25.00 lakhs will be invited publicly with Pre Qualification Criteria by publishing NIT and Tender on www.mumbaiport.gov.in and www.eprocure.gov.in The Registered contractors are exempted from submitting the Pre Qualification documents for works costing upto Rs.1.00 crore subject to the Specialities they are registered with this Port Trust.
