## **CIRCULAR**

To, (As per list attached)

> Sub: Concessional coastal tariff for ships and cargo that move from one Indian Port to another Indian Port through the territorial waters of Sri Lanka or Bangladesh in terms of Notification No.38/2018-Customs (N.T.) dated 11.05.2018 issued by the Central Board.

In view of TAMP's order No.TAMP/53/2015-VOCPT dated 25.09.2018, kindly note the insertion of the following conditionalities on the above subject, in the existing Scale of Rates of all Major Ports Trusts and BOT operators operating thereat in the General terms and conditions under Section 1.2:

- (i) Coastal goods transported between an Indian Port on east coast and another Indian Port on West coast or vice versa, by a vessel through the territorial waters of Sri Lanka, whether or not calling any port in Sri Lanka in between and without change of vessel in terms of Notification No.38/2018-Customs (N.T.) dated 11.05.2018 of Central Board of Indirect Taxes and Customs shall be eligible for concession in vessel related charges and cargo related charges.
- (ii) Coastal goods transported between an Indian Port on East coast and a river port in India or vice versa, by a vessel through a route passing through the Bangladeshi waters and without change of vessel in terms of Notification No.38/2018-Customs (N.T.) dated 11.05.2018 of Central Board of Indirect Taxes and Customs shall be eligible for concession in vessel related charges and cargo related charges.

(iii) The provisions prescribed above shall be subject to adherence to the provisions prescribed in the Order No.TAMP/53/2015-VOCPT dated 26.11.2015 and amendment Order No.TAMP/53/2015-VOCPT dated 10.06.2016.
