Sub: Storage facilities for import agri products.

Ref: This office Circular No.TM/D/4-3/19 dated 14.08.2018.

Vide this office circular referred above, the facility of storage of import agri products in the notified areas upto a maximum period of 180 days was extended for a period of one year from 01.08.2018.

2. The Board has accorded approval for the extension of the facility of storage of import agri products in the notified areas upto a maximum period of 180 days for a period of one year from 01.08.2019 on recovery of charges as under –

Location	Period of Storage	Rate per Sq. Mtr. or part thereof, per month or part thereof (in Rs.)
Sheds	First 30 days or part thereof	68.00
	31st day to 180th day	136.00
Open Yards	First 30 days or part thereof	51.00
	31st day to 180th day	102.00

In the event of non-clearance of the consignments within the period of 180 days, demurrage shall be recovered from 181<sup>st</sup> day onwards at the rates specified in Section 3.1 (B) of Chapter III of the Scale of Rates, subject to revision / modification from time to time.

- 3. For the areas covered under GBL, storage will be limited upto 180 days as approved by TR No.168 dated 17.03.2012 and the rates leviable will be . Rs.1.50 per sq. mtr. per day for first 15 days and Rs. 2/- per sq. mtr. per day for 16<sup>th</sup> day to 180<sup>th</sup> day; whereafter charges @ Rs. 20/- per sq. mtr. per day will be leviable from 181<sup>st</sup> day onwards as conveyed vide circular No. TM/D/4-3/ 01 of 2012-13 dated 10.04.2012.
- 4. It is requested to note that Scale of Rates (SOR) is under revision and revised charges as approved by the TAMP will be applicable from the date of revision of SOR, from time to time.
- 5. The above scheme will remain valid for a period of one year from 01.08.2019.
